PLAINTIFF'S ORIGINAL PETITION

TO THE HONORABLE JUDGE OF SAID COURT:

COMES NOW HOUSTON'S 1ST CHOICE AUTO AUCTION, Plaintiff, complaining of CHRISTOPHER G. MUFARRIGE d/b/a CNJ AUTO FINANCE, Defendant, and for cause of action shows:

I.

Plaintiff, HOUSTON'S 1ST CHOICE AUTO AUCTION, does business in Texas.

Defendant CHRISTOPHER G. MUFARRIGE is an individual that does business as CNJ AUTO FINANCE in Texas that may be served with citation at **15803 TOMBALL PKWY, HOUSTON, TEXAS 77086.**

Plaintiff elects to conduct discovery under Texas Civil Rule of Procedure 190.2.

This Court has jurisdiction over the parties and amount in controversy.

II.

Defendant and/or his authorized agents, purchased from Plaintiff motor vehicles described in **Exhibit "A"** attached. The Defendant signed and delivered to Plaintiff drafts, and thereby ordered the drawee bank, to pay to the order of Plaintiff the total of \$194,000.00 for the purchase price of the vehicles. A true and correct copy of each draft is attached hereto as **Exhibit "A"** and incorporated

by reference the same as if fully copied and set forth at length. Plaintiff is the legal owner and holder of the drafts. The drafts were drawn by Defendant for the purchase of motor vehicle. In reliance on the drafts given by Defendant as payment, Plaintiff turned over possession of the vehicles to Defendant.

III.

The drafts were duly presented by Plaintiff to the drawee for payment, but the drafts were not paid and were returned to Plaintiff by Defendant's bank unpaid and remain unpaid. Defendant has refused to return the vehicles, and Plaintiff believes the vehicle may have been sold to retail purchasers without benefit of the original title certificate.

IV.

Despite demand for payment, Defendant refused to pay the drafts or otherwise pay for the vehicles.

V.

Because of Defendant's failure to pay the drafts given to Plaintiff as payment for the purchase from Plaintiff of the motor vehicles, Defendant is liable to Plaintiff for the sum of \$194,000.00 after the deduction of all lawful payments and offsets.

VI.

Pursuant to Sec. 503.033 Texas Transportation Code, Plaintiff is entitled to recover reasonable attorney's fees for services rendered in the trial of this cause.

WHEREFORE, PREMISES CONSIDERED, Plaintiff requests that the Defendant be cited to appear and answer, and that on final trial, Plaintiff have:

1. Judgment against CHRISTOPHER G. MUFARRIGE d/b/a CNJ AUTO FINANCE


for \$194,000.00 with prejudgment interest at the legal rate;
